

Correction to Appendix 2A Previously Issued

SYDNEY, AUSTRALIA (23 March 2022)

Melbana Energy Limited (ASX: MAY) (**Melbana**) advises that the Appendix 2A provided to ASX on 22 March 2022, titled “Application for quotation of securities – MAY” requires correction.
